Topic: The United States should require vaccinations for all children

# Affirmative Case (Pro side):

1) Introduction (30 seconds): Requiring vaccinations to all children will benefit the children, parents and community as a whole. According to Centers for disease control and prevention in May of 2017, "Vaccines help develop immunity by imitating an infection, but this "imitation" infection does not cause illness. It does, however, cause the immune system to develop the same response as it does to a real infection so the body can recognize and fight the vaccine-preventable disease in the future".

- 2) Resolution Analysis (20 seconds if needed): The United States should require vaccinations for all children because they help save children's lives by protecting them against the spread of a disease and save both the child and parent money and time.
- 3) Aff Issue 1: A vaccines purpose is to save a child's life and protects against the spread of diseases; therefore, it should be required. According to The American Academy of Pediatrics states that in 2016" [vaccinations] have kept children healthy and have saved millions of lives for more than 50 years. Most childhood vaccines are 90% to 99% effective in preventing disease. And if a vaccinated child does get the disease, the symptoms are usually less serious than in a child who hasn't been vaccinated".

Harm: If children do not get vaccinated, their health and life could be at risk. According to The American Academy of Pediatrics in 2015, "when children are not immunized, the results can be devastating. Each year, thousands of children in the United States become seriously ill with diseases that could have been prevented with proper immunizations".

Solve: The United States should require vaccination for children as it benefits children and saves their life if they were to be exposed to a disease that might be surrounding them.

4) Aff Issue 2: Requiring all children to be vaccinated will save both the child and the parent time and money. According to Vaccines Today in 2016, "A new study says every dollar spent on vaccination saves up to \$44 dollars by reducing healthcare spending and productivity loss, and curbing the broader economic impact of illness".

Harm: If vaccinations do not become required, the amount of vaccinated children will drop which could mainly affect the child's health. Along with the child's health, financial loss can occur due to lost time at work or a long term disability which could have been easily prevented in the first place.

Solve: Requiring children to be vaccinated is a good policy as it will benefit the child, parent, and even the community significantly.
